New Business:

Scott Doane, on behalf of Jason Scott from Greyhawk Development, LLC, is requesting a Site Plan Approval Extension of Time for the Cedar Creek Cove Apartments. Mr. Nusser sited Covid and material availability and inflation as to delays in the project. Mr. Scott asked for two and a half years, Mr. Nusser recommended two years. The two years will from the one year lapse period. Substantial Sitework and utilities must be completed within the two year time frame or they must return to request another extension.

There were questions about the timeframe of the site plan approval. Mr. Nusser stated that Site Plan Approval is good for one year, whereas a Zoning Permit Approval is good for two and a half years and must have construction started within one year.

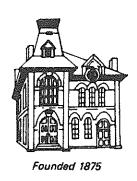

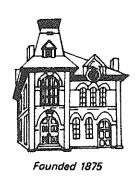

Mr. Crandall advised the Board that the future land use plan is 13 years old and they should be a planning commission instead of a reactive commission and try to envision what they would like to see going forward for the growth of this community.
